**BY MAIL or DROP OFF**

Complete the application form below, verifying that the information is correct. Please return the form including a **current rabies certificate** and a check or money order for the total amount due payable to the **Town of Westwood** either by US postal mail or drop in the Green mailbox in front of Town Hall, 580 High Street, Westwood.

**IN-PERSON**

Come to the Office of the Town Clerk during office hours. Bring rabies certificate and this completed application with you.

**ON-LINE**

Credit card payments only and there is a per license convenience fee that will be applied. Rabies certificates are required and may be mailed, faxed or emailed to [townclerk@townhall.westwood.ma.us](mailto:townclerk@townhall.westwood.ma.us).

All dogs six months or older residing in the Town of Westwood must be licensed. Licenses must be renewed annually and are valid from January 1 thru December 31. **No license will be issued for a dog not having a current rabies vaccination.** The license fee will be waived for those residents 70 years of age or older per Town bylaws §184-10.C.(2) (one dog per household, excluding Kennels) and for service dogs, provided necessary paperwork is given. For these exemptions you may apply by mail provided proof is included or you may apply in-person, at the Town Clerk's office. Purchased licenses are non-refundable and non-transferable. Tags must be worn by dogs at all times. If your dog should become lost, please contact **Public Safety Communications at 781-320-1000 or [dispatch@westwoodpd.org](mailto:dispatch@westwoodpd.org)**.
