Bring this completed form (**both sides**) to the County Auditor's Office (Lancaster), Dog Adoption Center (Lancaster), or Pickerington Title Office. **Addresses and hours are listed on the back.**

Annual dangerous dog licenses are only available in person at the County Auditor's Office. The fee is \$50 by January 31st and \$100 after.

**MAIL**

Mail this completed form (both sides) to the *Fairfield County Auditor, 210 East Main Street, Lancaster, Ohio 43130* with a check or money order made payable to the Fairfield County Auditor. To avoid the late fee, applications must be postmarked by January 31, 2025.
