ON-LINE

Register your dog on-line at www.doglicenses.us/OH/Marion. A per license processing fee applies. Please allow up to 3 weeks to receive your tag by mail. To access your pre-filled form you will need your Account ID and Password listed below:

2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form.
3. Enclose a check or money order for the correct fees payable to The Marion County Treasurer. **DO NOT SEND CASH FOR MAILED APPLICATIONS, Enclose a self-addressed stamped envelope with 2 stamps on the return envelope.**

Qualifying for Altered Premium Discounted Rates

Proof is required on the initial registration for a discount. To qualify for the discount your dog must be "Spayed/Neutered" with Veterinarian letter referencing spayed/neutered status. ***FIRST TIME EXEMPTION IS NOT AVAILABLE ONLINE.***

Certificates of registration and tags shall be valid only during the CALENDAR YEAR or YEARS for which they are issued. ORC Sec 955.09.
