**INSTRUCTIONS FOR RICHLAND COUNTY 2024 DOG LICENSES:**

**IT'S THE LAW (ORC 955.01)**  
All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag. (The law applies regardless of whether the dog is kept inside or out.)

**IN PERSON OR BY MAIL**

1. Complete this form. Include the correct owner, street and mailing address, and pet description(s) on the application.
2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
3. If you no longer own the dog(s) please contact our office or make the correction on this form and return to our office.
4. Enclose a check or money order **along with a self-addressed stamped envelope** for the correct fees payable to: **Richland County Auditor**. Please do not send cash. **January 31, 2024**, will be the last day to purchase at the licensing rate of \$18.00 per dog. **After January 31, 2024**, statutory late penalty increases the licensing rate to \$36.00 per dog.
5. Please return the application along with a check or money order to: Richland County Auditor; 50 Park Avenue East, Mansfield, OH 44902. A receipt will be returned to you with your 2024 license tag(s).

Allow for a couple weeks to process and license tags to be mailed from the Auditor's Office.
