## INSTRUCTIONS FOR WOOD COUNTY KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

## IN PERSON OR BY MAIL

- 1. The numbers reported by breed below should include each dog more than three months of age.
- The \$70 kennel fee includes five individual dog tags. Each additional tag costs \$1 each. Please enclose a check or money order for the correct fee payable to Wood County Auditor. DO NOT SEND CASH.
  After January 31, the statutory penalty increases the price of each kennel license to \$140. Processing of the license requires the correct fee.
- 3. Please return the application, check or money order, and self-addressed stamped envelope in the enclosed return envelope. A receipt will be enclosed with your 2025 license tag(s).

Tags may be purchased in person only or by mail at the Wood County Auditor's Office, second floor, County Office Building, Bowling Green (Office hours 8:30 a.m. - 4:30 p.m. Monday thru Friday). Please bring the attached form when purchasing tags. The District Board of Health has adopted a regulation requiring all dogs be immunized against rabies.
